

Dear Residents:

I hope you all have been enjoying your summer. As always, please be mindful of our children and drive carefully through our Village.

Security and Safety:

In our continuing efforts to reduce the amount of traffic cutting through the Village, we plan to install, (on a trial basis) “No Right Turn” signs that prohibit southbound traffic that has entered the Village at The Locusts, from turning onto The Oaks or The Birches during the evening rush hours (4-6pm). In addition, “No Left Turn” signs will be installed on Diana’s Trail at South Branch between 7-9am to discourage those who have started using this route as an alternate to The Spur during the morning rush hours. We will monitor these locations and request additional enforcement from our local precinct.

Village Boards:

The Board of Zoning Appeals (BZA), which handles important variance applications, is in need of two additional (alternate) Members. If you have any interest in getting involved and learning more, please reach out to the Village staff who will be able to address your questions and provide helpful information.

Taxes:
