

Village Elections:

As always, we will keep Village Hall opened all day (6:00am until 9:00pm) for your convenience. Positions that are up for election are 2 Board of Trustee seats as well as the position of Village Mayor. I would invite all registered voters to participate in this year's election.

Our Village Roads:

A reminder to all about a few things:

1. Please drive cautiously throughout the Village, particularly in the evenings, as the Village tends to be a bit dark, and our roads are winding.
2. If you are planning to have company, please ask your guests to all park on one (your) side of the street, as our roads are narrow and difficult to navigate. This will, among other benefits, allow emergency vehicles to pass.
